### Afrobarometer

Findings from Afrobarometer's special access to justice survey module are in, and they are sobering: In most African countries, substantial barriers still inhibit citizens' access to justice. Based on national surveys in 36 African countries, the new analysis identifies long delays, high costs, corruption, the complexity of legal processes, and a lack of legal counsel as major obstacles for citizens seeking legal remedies. While countries differ greatly in the extent and quality of their citizens' access to justice, even the best-performing states have substantial work to do before they can claim to meet the United Nations Sustainable Development Goal 16 call for "access to justice for all."

These findings are part of a new report titled "Ambitious SDG goal confronts challenging realities: Access to justice is still elusive for many Africans," published March 13 as Policy Paper No. 39 by Afrobarometer, the world's premier source of reliable data on public perceptions and attitudes across Africa. Country-specific analyses for six fragile and conflict-affected countries (Burundi, Côte d'Ivoire, Mali, Niger, Sierra Leone, and Togo) will be published over the coming weeks.

Global Engagement Speaker Series Wednesday, March 15th, 2017 12:30pm in 110 Chittenden Hall

Born in Uganda, Odora Hoppers first studied in her home country and in Zam bia before becoming a Swedish citizen and completing her doctorate in social sciences at Stockholm University. She has since forged a multifaceted career as a scholar and policy adviser, serving many leading international organizations in education, gender policy, disarmament, and intellectual property rights. Professor Hoppers received the Nelson Mandela Distinguished Africanist Award in 2015. The award is given to an African who has distinguished himself or herself in public leadership positions. Hoppers's principal areas of interest include: building capacity for trans-disciplinary basic and applied research in support of Africa's development; providing support to policy formulation and implementation for sustainable development and human security in Africa and internationally; promoting the social and economic justice agenda including the rights of local communities; and promoting dialogue across cultures and epistemologies by developing protocols for respectful cultural exchange, strengthening the enfranchisement of Africans, and promoting endogenous research.

### GJEC Fellowships for Dissertation Research & Completion

The Gender, Justice, and Environmental Change (GJEC) Program, at the Center for Gender in Global Context (GenCen), is pleased to announce fellowships for MSU graduate students for the 2017-18 academic year. Generous funding provided by MSU's Graduate School allows us to offer four fellowship opportunities of up to \$10,000\*\* in the following two categories: GJEC Dissertation Research Fellowship

Eligibility: Ph.D. students at MSU who have completed all requirements for their degree with the exception of their dissertation research. Applicants must have dissertation projects that focus specifically on the gender dimensions of environmental and/or agricultural change. GJEC Dissertation Completion Fellowship

Eligibility: Ph.D. students at MSU who have completed dissertation research and all other requirements for their degree program, except for completion of the dissertation. Applicants must graduate by Spring 2018, and their dissertations must focus on the gender dimensions of environmental and/or agricultural change.

Association for the Study of the Worldwide African Diaspora (ASWAD) 9th Biennial Conference Hosted by Pablo de Olavide University Seville, Spain November 7-11, 2017 Seville, Spain Call for Papers

African/Diasporic Futures: Re-Envisioning Power, Interventions, Imaginations and Belonging

In 2015 the United Nations launched the Decade for the People of African Descent to acknowledge descendants of the African Diaspora as a distinct group whose hum an dignities and rights have been violated throughout the globe. The Decade for the People of African Descent is a sustained global commitment to recognize, protect, and bring about inclusive social justice to members of the African Diaspora. Contemporarily, Europe is an epicenter of such urgent grappling with systematic and long-term social inequities. Politics and policies of racialized exclusion, particularly through its engagement with Africans and people of African descent, re-center Europe's non-neutral racial projects in their nation building.

The protection and promotion of human rights has gained greater significance and urgency with the crisis of African migration, and other forced and semi-forced migrations from Western Asia and Eastern Europe. As these individuals and groups have sought refuge and equitable and humane social participation within European societies, they have challenged conceptualizations of the state and citizenship formation, and continue to force new articulations and notions of "home" and belonging. These current migratory flows are newer iterations of a long relationship between Europe and Africa, and between Europe and the African Diaspora that spans centuries.

ASWAD invites panel and individual paper proposal submissions for its 9th biennial conference to be held in Seville, Spain, November 7 to 11, 2017 on the campus of Pablo de Olavide University to discuss, examine, and reflect on the critical nature of the interactions and transformations that African descendants experience in their diaspora, particularly within a European context. As an interdisciplinary organization, ASWAD invites presentations that illuminate the lives of Africans and African descendants from scholars of any discipline, including social sciences, physical sciences, life sciences and performing arts. We aim to collaborate with activist and intellectual communities around sustained dialogue involving diaspora, race and citizenship, and historical and contemporary patterns of racial formation.
