

Born in Uganda, Odora Hoppers first studied in her home country and in Zambia before becoming a Swedish citizen and completing her doctorate in social sciences at Stockholm University. She has since forged a multifaceted career as a scholar and policy adviser, serving many leading international organizations in education, gender policy, disarmament, and intellectual property rights. Professor Hoppers received the Nelson Mandela Distinguished Africanist Award in 2015. The award is given to an African who has distinguished himself or herself in public leadership positions. Hoppers's principal areas of interest include: building capacity for trans-disciplinary basic and applied research in support of Africa's development; providing support to policy formulation and implementation for sustainable development and human security in Africa and internationally; promoting the social and economic justice agenda including the rights of local communities; and promoting dialogue across cultures and epistemologies by developing protocols for respectful cultural exchange, strengthening the enfranchisement of Africans, and promoting endogenous research.

GJEC Fellowships for Dissertation Research & Completion

The Gender, Justice, and Environmental Change (GJEC) Program, at the Center for Gender in Global Context (GenCen), is pleased to announce fellowships for MSU graduate students for the 2017-18 academic year.

Generous funding provided by MSU's Graduate School allows us to offer four fellowship opportunities of up to \$10,000** in the following two categories:

GJEC Dissertation Research Fellowship

Eligibility: Ph.D. students at MSU who have completed all requirements for their degree with the exception of their dissertation research. Applicants must have dissertation projects that focus specifically on the gender dimensions of environmental and/or agricultural change.

GJEC Dissertation Completion Fellowship

Eligibility: Ph.D. students at MSU who have completed dissertation research and all other requirements for their degree program, except for completion of the dissertation. Applicants must graduate by Spring 2018, and their dissertations must focus on the gender dimensions of environmental and/or agricultural change.

Funding must be used during the 2017-18 academic year. Applications are due April 15, 2017, and are available at www.gencen.msu.edu/funding/gjec.htm.

International Studies and Programs (ISP) Student Funding Opportunities Deadline: March 1, 2017

In an effort to continue to internationalize the student experience, ISP takes pride in helping to support students who are interested in working on the world's greatest problems. Here are some internationally focused funding opportunities, administered by the ISP Dean's office, for undergraduate and graduate students.

Claffey Meyer International Travel Grant (doc)

This award provides financial assistance to domestic students who intend to travel to developing countries for the purpose of providing technical assistance, participate in research, or engage in service. The intent is for students to work towards discovering and implementing solutions in response to urgent human needs (for example: food security, environmental quality, health and nutrition, education, and other areas) and, thereby, to encourage careers in international development teaching, research and practice. Grants are intended to support travel, related living expenses, and projects costs, not to be used as a tuition scholarship.

David D. Horner International Student Scholarship Fund

A scholarship fund reserved for international students in financial distress due to circumstances beyond their control, which may jeopardize students' ability to remain at MSU.

Dr. Charles and Marjorie Gliozzo Dissertation Research Scholarship

This scholarship is available to MSU doctoral students with dissertation research objectives who have defended, or are in the process of defending, a dissertation proposal. The scholarship supports field research abroad in support of the student's dissertation.

Office of the Vice President for Research and Graduate Studies Discretionary Funding Initiative (DFI)

Deadline: March 2, 2017

The Discretionary Funding Initiative (DFI), funded by the Michigan State University Foundation, provides bridge funds for tenure stream faculty for additional studies needed for resubmission of an unsuccessful, but nearly fundable, grant application to the same funding agency. To request funding from this program, faculty should submit a request to the research associate dean of their college (lead college, if appointed in multiple colleges) using the DFI information form attached to this email. Applicants will be expected to provide copies of their previous external reviews, if applicable, and describe the work that will be completed to address the comments provided in these documents.

Requests for support approved by the research associate deans will be forwarded to the Office of the Vice President for Research and Graduate Studies in a prioritized list. The maximum award from the OVPRGS will be \$25K and will require a 100% (up to \$25K) match from units or colleges. The PIs of the recommended projects will be required to submit an electronic transmittal. Funds will be available for 18 months, and an

activity report will be required at the end of the granting period.

The Association for the Study of the Middle East and Africa (ASMEA) is offering the following Grant Opportunities in conjunction with the Tenth Annual ASMEA Conference on October 19 - 21, 2017 in Washington, D.C.

Research Grants

ASMEA is offering research grants of up to \$2500 to qualified professors and students engaged in the study of the Middle East and Africa. Applications must be accompanied by a paper proposal that represents new and unpublished research and is relevant to the qualifying research areas designated by ASMEA. Successful research grant applicants are required to present their research at the Tenth Annual ASMEA Conference and provide ASMEA the right of first refusal for potential publication in our peer-reviewed Journal of the Middle East and Africa.

To stimulate new and diverse lines of discourse about the Middle East and Africa, ASMEA's Research Grants Program seeks to support research on topics that deserve greater attention. The topic areas and sub-topics listed below are intended as a guide for potential participants in the program and constitute the types of subjects that ASMEA intends to support. An applicant may submit a proposal on any topic as long as it is directly relevant to the five broad areas outlined and constitutes new and original research: Status of Minorities and Women, Modern Military History, Governance and Economy, Belief, and Personal Status.

Travel Grants

ASMEA is offering travel grants to qualified scholars and students whose paper proposals are accepted for presentation at the Tenth Annual ASMEA Conference. Grants of up to \$750 are available for international applicants while U.S. applicants may receive grants of up to \$500.

Center for Advanced Study of International Development International Strategic Partnership Funding

Deadline: March 1, 2017

The Provost and Associate Provost and Dean of ISP have made funding available to develop international strategic partnerships with universities and institutions of higher education and research abroad. The funding is focused on the international themes of food and agriculture, environment, health and nutrition, and education. These partnerships should involve MSU faculty from multiple disciplines and fields of study. Collaborations focused on these international themes that involve faculty from Arts and Letters or Social Science are encouraged. Partnerships should center on collaborative research, including proposal development and preliminary research activities that build institutional capacity and strengthen the institutional partnership.

Strategic partnerships should ultimately lead to potential long-term research and other collaborations between MSU and the partner institution. Grant development can be facilitated by CASID staff in collaboration with involved units. Funding may be granted for continued support to develop these partnerships, depending on the outcomes of the initial grant.

Rethinking the Afropolitan: The Ethics of Black Atlantic Masculinities on Display

College of the Holy Cross, Worcester, MA Friday, October 20th and Saturday October 21st, 2017

A 21st century term, "Afropolitan," already is charged with contested meanings. Celebrated by some as the pinnacle of African modernities, others see the Afropolitan as a glorified consumer or perennial object of Western consumption. However, most discussions of Afropolitans have occurred in relation to the arts, literature, and fashion and almost exclusively in relation to Africans in Western cities or Westernized enclaves in Africa in the present. A historicized approach to the concept of the Afropolitan raises new questions about how scholars and activists read race, gender, identity, and ethics in images and texts. We challenge our participants and audience to historicize and complicate the idea of the Afropolitan and the controversies it has engendered. Our conceptualization of the Black Atlantic incorporates people of color and the range of communities they form among themselves and with others across the African and European continents and the whole of the Americas and the Caribbean.

Submissions need not be confined to these topics, but, if possible, please indicate at least two themes that correspond to your proposal:

The Politics of Performance (Visual, music, and multimedia arts; Performing citizenship; The art of athletics)

Redefining the Black Atlantic (Transnational networks, Geographies of power, Beyond empire)

Sexualities (Bodies of knowledge, Politics of desire, Trans-networks)

Men in Labor (Histories and legacies of slavery, Policing work, Representing leisure and resistance)

Fatherhoods and Families (Affective ties, Iconic mothers, Blended families)

The Politics of Religion (Disciplining bodies, Ethics of redemption, Gendered representations of the divine)

Reproducing Bodies (The economics of citizenship, Symbolism and consumption, Criminalization and mass incarceration)

Theories and Male Models (Space and mobility, Politics of community organizing, Self-fashioning beyond genders)

Education without borders? Frictions and boundary-crossing in the field of internationalised education

Panel at the 2nd Transmobilities & Development Conference: Frictions in a mobile world, Radboud University, Nijmegen, 8-9 June 2017

Description:

The education field, across secondary, territory and professional levels, has become increasingly internationalised. The field is traversed by intersecting flows of people (students, staff and administrators), other tangible materials (money, books and other learning materials, equipment etc.) and intangible elements

(money, knowledge, teaching and learning philosophies and techniques, management practices etc.). In migration/mobilities research, internationally mobile students have been the focus of many studies in the growing research field. While these students are generally viewed as an unproblematic migrant category, research has also shown the unevenness and 'darker' sides of their mobility experiences. Together with mobility, frictions and social boundary-crossings also define, in intersecting and contingent ways, the lived experiences of these mobile students. The is true for other elements in the field, e.g. institutions, practices, staff, curricula, knowledge, resources, skills and profits as well - they do not just flow across borders as often propagated but experience (and generate) frictions and (new) boundaries. The mobility and frictions of these various elements in turn shape the production, circulation and consumption of education and knowledge. It is important to examine how and why some elements cross social and geographical boundaries, while other elements are more difficult to mobilise and transfer into new contexts. This panel seeks to address the ways in which the frictions are created, experienced and resisted. How do these frictions affect geographies of knowledge and power? Who benefits from frictions? And who gets blocked? Can frictions also be creative? What are the implications for local education sectors and labour markets? Which policies and agendas have eliminated frictions and/or produced new ones? We are keen to receive abstracts from researchers interested in one or more of these questions.

Africa and the World: literature, politics, and global geographies A Summer Institute for Educators June 14 - 17, 2017

African countries are often negatively portrayed in Western media and only make an occasional appearance in countless social studies textbooks in U.S. schools. Even fewer K-12 and community college curricula demonstrate the cultural riches and diversity of the continent. But literature is arguably one of the most powerful tools educators could use to broaden students' understanding of African cultures and societies.

The place of African writers in the primary and secondary classroom is typically limited to short explorations of

a single author, often treated as representative of the entire continent. But in the post-secondary level, African literatures broadly defined should engage questions of what it means for a body of creative work to be framed as regional, national, "postcolonial", or "world" in a globalizing context. In collaboration with the African Literature Association's (ALA) annual conference, the institute will offer a four-day intensive program for K-12 and community college educators who are passionate about using creative literary works to explore Africa's complex social histories, politics, and cultural identities. The institute may be of particular interest not only to English/Language Arts educators, but to Social Studies and other Humanities teachers looking to creatively incorporate literature, poetry, or drama into their curriculum.

Participants will have access to notable African authors and leading literary scholars who will present on themes of migration and creative writing, the teaching of canonical African texts, film in the classroom, and poetry and performance. Participants will also have the opportunity to attend select events within the larger ALA conference.

The institute will offer a broad range of resources for teachers interested in integrating this content into their classroom curriculum. These include pedagogical workshops on how to analyze and teach literary sources from Africa, as well as how to utilize materials from the Yale Beinecke Rare Book and Manuscript Library and the Yale University Art Gallery.

A Curriculum Advisor will also form an integral part of the program to assist participants in authoring their own curricular units, which can potentially be published on PIER's website as resources for outside educators.

Call for Submissions: Poems and Essays on Being Black and Bicultural

We are accepting submissions for a new book on being Black or African and bicultural. We are accepting submissions from authors who self-identify as Black, and who navigate multicultural Black spaces to varying degrees over time. The book uses a Pan African lens to examine what it means to be Black or African. Meaning, what it means to inhabit a Black or African racial identity, but inhabit multiple Black or African cultural identities. The book will highlight the experiences of Black people with different cultural backgrounds and experiences. This includes individuals with one parent from one part of Africa or the African Diaspora, and one parent from another part of Africa or the African Diaspora, individuals with both parents born in Africa or the African Diaspora who grew up in a country other than that of their parent's birth, as well as individuals with other bicultural or multicultural backgrounds.

We are accepting original (previously unpublished) poetry and essays. Essays should be no more than 5,000 words and should be reflections on the experiences and/or observations of the author. For poetry, please submit no more than 2 poems.

Essays should begin by reflecting on how authors self-identify. Essays should then focus on answering at least one of the following questions:

- Have you always had a dual identity, or have you moved between both identities?
- How has being bicultural framed your identity?
- How did your adolescence differ from that of your peers?
- How has being bicultural shaped your activism?
- How has being bicultural framed what is means to be Black or African in for you?
- How did being in a bicultural household shape how you were raised?
- How have your experiences shaped your adoption of one culture over the other, or your adoption of both cultures?
- How have your dating experiences or patterns been impacted by you being bicultural?
- How has your cultural background impacted how you have raised, or will raise, your children?
- How have racial constructs of society impacted you?
- How has being bicultural impacted your relationship with both communities?

Deadline for the submission of completed poems and essays is June 1.
